We will not take part in or allow any member initiation.

Unless caused by the actions or inactions of the CCSAI, or those for whom it is in law responsible, release, hold harmless, and indemnify the CCSAI from and against any actions, claims, suits or other demands and against all costs, damages, expenses or losses which may be incurred or sustained by the CCSAI as a direct or indirect consequence of any events or activities, sponsored or activities by the CCSAI and whether such activity or event occurs on or off the college premises.

In the event that we violate any of the above, we understand that the club will be subject to sanctions up to and including dissolution. We are also aware that the club may be dissolved at any time as a result of a two-thirds majority vote from the CCSAI Board of Directors and agree to these terms.

We may appeal any CCSAI Board of Directors' decision via By-Law #4 - Judicial Committee
